Accomplishments	Greece Doctor Pantelis Sarafidis, MD, MSc, PhD is an Associate Professor in Nephrology in Aristotle University of Thessaloniki, and Honorary Consultant in Nephrology in Hippokration Hospital, Thessaloniki Greece. He is the Head of the ESH Hypertension Excellence Center in this hospital. The research activities of Dr Sarafidis are focused on hypertension,
	diabetic and hypertensive nephropathy, acute kidney injury, polycystic kidney disease, anemia in CKD, and cardiovascular disease in CKD. He has participated as principal or sub-investigator in numerous observational studies and clinical trials in the above fields. He has supervised to completion five PhD research projects and he is currently supervising another four. He has authored more than 270 articles in peer-reviewed international medical journals and book chapters in international textbooks, and performed more than 220 lectures in national and international meetings in the areas of Nephrology, Hypertension and related fields. As of today, his international papers have received 6133 (Scopus) / 9628 (Google Scholar) citations and his Hirsch index is 43 and 53, respectively. He is currently a reviewer for more than 60 international medical journals and serves in the Editorial Board of six of them.
